- B. Regular Agenda
  - a. Senate Bill 1128: Senator Bayer - Increase in pay for Parliamentarian and Pro Temp Positions. Today we are looking at \$25 per semester. Pro Temp perform more duties than a senator. Currently \$150 per month Aug 2017-April 2018. Amount is at equal to Senator and should be paid compensation in which reflect the duties of the position. Hereby enacted that the Parliamentarian and Pro Temp salary be increased and be paid \$175 per month Aug 2017-April 2018 Pro Temp be increased be it reflected on their

responsibilities. President Harmon: added very early in term with Trujillo pro temp and has taken on more responsibility job responsibilities and should be compensated for that more.

i. Senator Becker: How many more additional hours are Pro Temp and Parliamentarian taking?

1. Pro Temp Roberts: Documenting reports made sure done the way they were supposed to while in contact with President and Vice President. Making sure all people are involved and everyone is on same page. Exact times unsure but responsibilities come with constant communication with everyone and everything is up to par as far as working with projects for the Senators.

a. Senator Becker: That would be a \$5 a week pay increase and should be move up more.

i. Vice President Trujillo: Budget is low this year. Payment is based off of service work.

ii. Parliamentary Ettleman: This extra pay goes into any extra work they have to do and expectations are higher. It is more rigorous this year and time consuming.

b. Senate Bill 1129

i. Increase in salary to better reflect Parliamentarian job responsibilities.

1. Pro Temp Roberts-Speak to the position- Have to scour all rules of order. Understanding that alone is very difficult. Making sure everybody knows how to move forward with those in itself is very time consuming. The Parliamentarian puts in extra work during school year.

a. Vote motion to Secret Ballot: Motion made by Senator Freed and Seconded by Parliamentarian Ettleman.

i. Vote: 7 to 2 to 1 vote Passed

c. Senate Bill 1130

i. States to reinstate voluntary premise of Senate Aid positions. This has to do with the budget cuts of 10% or \$7,000 budget. To prevent decrease in pay of Senators and Directors it was thought best to take the money from the Senate Aid positions that we were allowing and help support the cut. \$2,800 moved from Senate Aid positions to Senates. Senate Aid positions become strictly voluntary. Whereby Here Incanted \$2,800 towards the budget cut.

1. Pro Temp Roberts: we created the positions to increase involvement in ASG for participations see to what was going on. A lot were disengaged and nothing to do outside of attending committee meetings. While great for participation but not for compensation.

a. Senator Bayer: My observation, didn't increase Senate Aids in ASG

- i. Senator Becker: Is there a plan in place to increase volunteering in ASG for greater impact?
  - 1. President Harmon: We are looking to broaden horizons for students and looking for voluntary work.

## B. ASG Updates

### a. Executive

    4. Director Ruiz: DACA Program threatened. Ten states are threatening to sue the Government if President Trump does not act in repealing the DACA Program because of undocumented students / children going to school and granted work visas for once graduated. Texas, Arkansas, Idaho, Louisiana, Kansas Alabama, Tennessee, South Carolina and West Virginia. Must act by Sept 5th or those ten states will sue the Government if President Trump doesn't act. allegiance to DACA students. Our proposal released tomorrow depends of DACA students.
